BY-LAWS

MEMBERSHIP. Eligible as member is any bona-fide amateur who has resided for at least six months within the borders of British Columbia. An applicant, lady or gentleman, must be proposed by two members of the Club, whereupon the application is passed on at a regular meeting of the Club.

MEETINGS. Regular meetings shall be held at least once a month during the season.

ORDER OF BUSINESS. The order of business at each meeting shall be based on the following program: (1) Reading of minutes of the last meeting; (2) Correspondence; (3) Unfinished business; (4) New business; (5) Fixing date for next meeting.

SPECIAL MEETINGS. Special meetings of the Club shall be held at the call of the President, or, in his absence, the 1st Vice-President, provided that two days' notice shall be given each member. All questions that are up for discussion at such meeting, shall be decided by ordinary majority, except as where otherwise provided. At a special meeting only such business as is described in the notice calling the meeting, shall be considered, discussed or acted upon. At least seven members shall be present to constitute a quorum.

VOTING. At regular as well as special meetings only members who have fully paid up their Club membership shall be entitled to vote. At the last (annual) meeting of each season vote shall be taken by ballot on open nominations for the election of officers. At special meetings, the vote shall also be by ballot, and no proxy shall be allowed.

In the election of officers should a tie vote occur, the presiding Officer shall cast the deciding vote.

OFFICERS. The officers of the Club shall consist of a president, a vice-president, a secretary and a

treasurer. In addition a suitable person of influence shall be elected Honorary President.

DUTIES OF OFFICERS. The President shall preside at all meetings of the Club. The Vice-President shall preside in the absence of the President. In the absence of President, Vice-President and the Secretary, a member of the Club shall be chosen to act temporarily.

THE DUTIES OF THE SECRETARY. To keep a complete record of the proceedings of the Club; to conduct under the direction of the President the correspondence of the Club; to perform such other duties as pertained to his office and as may be prescribed by the President. To compile a report of the activities of the Club for the past season.

THE DUTIES OF THE TREASURER. To receive all moneys due to the Club and to deposit same on the Club's account in specified Bank. To disburse all amounts authorized necessary for the proper carrying out of the affairs of the Club. To keep proper books of accounts and vouchers for all payments made: To prepare annually a statement for the past year showing the true financial standing of the Club, which statement shall be subject to proper auditing.

COMMITTEES. The Club shall appoint all committees that may be found necessary for the proper carrying out of the Club's functions. Meetings of any Committee may be called at any time by the president or chairman of such Committee, appointed in due order.

The President of the Club shall ex officio be a member of all committees.

DISBURSEMENT. All disbursements shall be made by cheques and cheques shall be signed by Treasurer and countersigned by President.

FEES. The annual fee per member shall be decided on the last meeting of the season (the annual meeting), for the next season. The membership fee

for the Season 1927 shall be \$1.00. The membership fee for the 1928 season shall be \$3.50. Each season shall start with the 1st of January on account of the fact that ski-ing can be enjoyed by Club members as late as in the month of June.

INITIATION FEE of \$1.00 must be paid by all new members who join the Club on or after January 1st, 1928. Those members who have joined the Club previously who have paid their dues before that date shall be regarded as chartered members of the Club and shall be exempt from paying such initiation fee.

EXPULSION OF MEMBERS. In the case of conduct of any member or members which, in the opinion of the majority of the Officers of the Club, is injurious to the character of the best interests of the Club, the Officers shall be in power to ask such member or members to withdraw from the Club.

DISSOLUTION OF CLUB. The Club may dissolve only at a regular meeting. Such resolution shall require unanimous vote to that effect. Notice of such intended dissolution shall be communicated by the Secretary to each member at least one month before the date set for the meeting. In the event of such dissolution decided upon, the disposal of the assets of the Club shall lie with the Officers.

RULES AND REGULATIONS

The Club, being duly affiliated with the Canadian Amateur Ski Association, which in turn is affiliated with the Federation Internationale De Ski, shall be governed by the Rules and Regulations of these bodies.

AMATEUR STATUS. An amateur skier must qualify as an amateur under the rules of the Canadian Amateur Athletic Union. The Canadian Amateur Ski Association has adopted this stipulation (February 27th, 1926) as being in the best interest of the ski sport. A member of the Club must abide by this rule, and an applicant for membership as well as an

applicant for a competition staged by the Club or under its auspices and sanction, may consequently be asked upon to produce his or her amateur card, before being admitted.

CLASSIFICATION OF COMPETITORS.

(c) Novice, (b) Intermediate, (a) Senior.

A *Novice* is an amateur who has never won a first prize in a novice or a prize in a higher competition.

An *Intermediate* is an amateur who has never won a first prize in an intermediate or a prize in a higher competition.

Senior. Any amateur may compete in this class, provided that in the opinion of the proper officials he is duly qualified.

The above classifications apply to both cross-country and jumping events but classification in one has no bearing on the other. A skier can compete for only one Club during a season except by a bona fide change of residence and a proper transfer from one club to another as provided by the rules of the Association.

COMBINED COMPETITIONS. In order to foster the proper spirit of ski-ing, the Club puts itself on record as fully in favor of combined competitions (cross-country and jumping competitions) in preference to jumping competitions only. This is prompted by the fact that ski-ing in Canada hitherto has been mostly confined to ski-jumping, the result of which has been that the public in general has obtained the altogether misleading idea that ski-jumping is the sole of the ski-sport. In the Club's opinion, cross-country racing should receive first consideration and should at least be practised on even terms with jumping. The Club in its desire to bring cross-country racing in Canada back to its proper place is particularly fortunate in having within its radio of activity the finest territory for cross-country ski-ing in the Dominion.

THE HOLLYBURN PACIFIC SKI CLUB HISTORY

The Hollyburn Pacific Ski-Club, with headquarters at Hollyburn-Pacific Ski-Camp, West Vancouver, British Columbia, was formed at a special meeting of a few ski enthusiasts at 615-Hastings Street West, Vancouver, B. C., on the 2nd of March, 1927, upon initiative of Rudolph J. Verne of Vancouver, supported by Mr. J. C. Johnson of New Westminster, B. C., and Mr. P. Johnson of Vancouver, B. C. On March 26th a constitutional meeting was called and the following officers were elected:

The Club decided to hold its first competition during the Easter holidays and a letter was despatched to the Canadian Amateur Ski Association in Montreal applying at the same time for affiliation with that body and sanction of the Easter meet. On April 15th a wire was received from Mr. H. P. Douglas, President of the Canadian Amateur Ski Association, giving official recognition of the Club and sanction of the proposed competitions and appointing the Club President a Vice-President of the C.A.S.A. These very encouraging news for our Club were followed by a letter from Mr. Douglas confirming the wire and giving expressions of good-will and well-wishes for the future of the Club, all of which was received

with great enthusiasm. The splendid sporting spirit thus showed us from the Association was heartily appreciated by our club members and of considerable assistance in getting a good start. The officials of the Club are particularly anxious to foster and develop the art of ski-ing on its proper and legitimate principles, and are fully supported by the members of the Club in this desire, and we are therefore very fortunate in having met with such splendid response from the part of the Association.
